## BAHM-member MBA programs educate the healthcare leaders who shape, drive and innovate the health sector worldwide.



BAHM schools offer a variety of graduate programs with a health sector focus. Because each program is structured differently, the method for recording the number of students and graduates varies across schools. The numbers above therefore reflect estimates.

The crisis of the COVID pandemic has revealed tremendous strengths and glaring failures of the healthcare system. Based on outstanding basic and translational research, we were able to develop and manufacture vaccines for this deadly virus in record time. However, the marketing science behind vaccine promotion lagged the clinical science in many markets. Digital tools such as telemedicine showed the remarkable latent innovation capacity in healthcare, yet business strategies continue to move us back to an ex-ante model of care delivery. Through all this, the continued reports of the glaring disparities in health outcomes across race and ethnicity, and across countries, drive a growing call for action and change. All of these results motivate the BAHM member schools to pursue their mission of developing leaders with the knowledge, leadership skills, and technical skills to drive our field forward.

Here are highlights of BAHM's recent milestones and a look ahead:

BAHM's journal, *Health Management, Policy and Innovation* (HMPI.org), is transitioning to a new editorial team following the passing of Will Mitchell, the journal's editor in chief. Will, a beloved professor at the University of Toronto's Rotman School of Management and a respected scholar in the global strategy and healthcare management field, spearheaded the journal's relaunch in 2017 and helped guide its growth and impact around the globe. We, Kevin Schulman and Kirsten Gallagher, have assumed the roles of editor-in-chief and managing editor, respectively. In addition, we have assembled a strong group of faculty members from our BAHM programs to serve as Senior Associate Editors. In a next step, we will be revamping the submission and review process and focusing on further broadening and strengthening the impact of the journal. We are determined to remainan open-source journal. Helping to support that goal, is a generous donation we received from the Ludy Family Foundation.

The BAHM case competition returned to an in-person event, with the option for students outside of North America to participate online. Baylor University's Hankamer School of Business Robbins Institute of Health Policy and Leadership hosted the competition in April 2022. Students worked collaboratively, many of them across campuses and continents, to compete for cash prizes as they envisioned the "Hospital of the Future." Bill and Mary Jo Robbins and the Robbins Foundation generously funded the event and also made it possible for students from INCAE Business School in Costa Rica to participate in person. It is our aim to make it possible for all BAHM programs, regardless of location, to be able to compete in what is now a truly global "Business of Healthcare" competition.

**Our strategic priorities are leveraging BAHM members' existing collaborations and their potential to grow.** Members have spearheaded new initiatives focused on showcasing faulty research, including junior faculty, exchanging more detailed curriculum information, facilitating engagement and learning opportunities for students across BAHM-member schools, and opening up BAHM's know-how and resources to other health management programs and their students. All these efforts serve our mission to advance health management education, research, and thought leadership.

**Finally, the ongoing refinement of our operational and accounting processes continues under the guidance of BAHM Treasurer Ned Rimer at BU Questrom's School of Business.** We have also engaged new operational assistance to support BAHM's expanding activities and growth. As an organization, we're excited to see BAHM mature and work to achieve the mission of supporting our member schools.

## **PROGRAM** NOTES

The Robbins MBA Healthcare Program at Baylor University's Hankamer School of Business brought the Army-Baylor University Graduate Program in Health and Business Administration into BAHM's member circle. Faculty from the Army-Baylor MBA Program, which is affiliated with Baylor's MBA Healthcare Program, will now participate in BAHM activities.

#### In other Baylor and Army Baylor news:

- The Army-Baylor MHA/MBA Program welcomed a new Program Director, LTC(P) Dan Wood. He succeeded COL Theresa Hinnerichs in September 2022. In other news, the Army-Baylor MHA/MBA program won the 2022 Higher Education Network Award at the American College of Healthcare Executives Annual Congress.
- The Robbins MBA Healthcare Program adds Global Health Immersion to its offerings. The program's inaugural trip was to San Jose, Costa Rica, during which 22 students, along with accompanying faculty and an advisory council member, engaged with fellow BAHMmember INCAE Business School. With input from Andrea Prado, INCAE health management professor, students visited a community clinic, Costa Rica's largest private hospital, and Medtronic's Costa Rican manufacturing facility. Andrea Prado also arranged a lecture with Alvaro Salas, the "father" of the Costa Rican healthcare system.



CU Denver Business School's Health Administration MBA program introduces a Global Healthcare Business course in partnership with the International Hospital Federation. This nine-week course provides students an in-depth look at global healthcare business and includes an international visit.



- ► The Indian School of Business's Max Institute of Healthcare Management, in collaboration with ISB Executive Education, launched two new programs:
  - Accelerating Digital Transformation in Healthcare (ADTH) is a topic-focused program for healthcare leaders seeking to leverage digital technology to create a renewed value proposition for their businesses. The first run in September 2022 attracted senior executives from providers, tech/consulting firms, and foundations.
  - The Certificate Programme in Healthcare Management (CPHM) is a 12-week asynchronous program positioned as a primer for first-time healthcare management learners delivered through the partner Emeritus.

Miami Herbert Business School MBA programs were awarded accreditation by the Association of MBAs (AMBA), only the third school in the United States to achieve this distinction.

On a separate note, the Health Management and Policy department is proud to note that its faculty includes two former Secretaries of Health and Human Services: Secretaries Donna Shalala, served in the Clinton Administration, and Alex Azar, who served in the Trump Administration. They will be co-teaching the Health Care Policy course in the school's Executive MBA in Health Management and Policy Program.

- The University of Minnesota Carlson School of Management's new Business Advancement Center for Health (BACH), led by Pinar Karaca-Mandic, engages interdisciplinary experts from academia, industry, and the community to design and evaluate business-driven innovations that address gaps of equity in healthcare. Two research projects are examples of the center's milestones to date:
  - The award-winning <u>COVID-19 Hospitalization Tracking Project</u> collected, tracked, and reported hospitalization data, which informed the public and policymakers during the pandemic. The project, which came to a close in August, received six awards and recognitions; had more than 650,000 website views; and resulted in 11 published studies, 140+ reports, and more than 275+ media citations including in the *New York Times, The Wall Street Journal, Bloomberg, NPR, Forbes*, and many others. Contributing to the project were 17 undergraduate and five graduate research assistants.

- BACH is leading a new research project, "Social Bonds as a Pooled Financing Mechanism to Address Social Drivers of Health Equity," funded by the Robert Woods Johnson Foundation. This three-year grant is focused on designing and evaluating a novel financial instrument to align Medicaid managed care organizations (MCOs) and establish sustainable funding for targeting social influencers of health (SIH), such as housing and food insecurity. The project is a collaboration between the Carlson School of Management and the Minnesota Hospital Association, with support from the Minnesota Department of Human Services, Minnesota Department of Health, Minnesota Council of Health Plans, Piper Sandler, PrimeWest Health, Amherst H. Wilder Foundation, Second Harvest Heartland, and StratisHealth.
- Yale University's Pozen-Commonwealth Fund Fellowship in Health Equity Leadership, an MBA degree-granting fellowship, is now in its fourth year. The fellowship covers the cost of the MBA for Executives program and gives healthcare practitioners the leadership skills and the deep understanding of teams, markets, and organizations necessary to tackle inequities in the U.S. healthcare system. The Fellowship includes a suite of educational, co-curricular, and practical experiences and activities that work in concert with a rigorous executive MBA program. These are designed to help accelerate the capabilities of emerging leaders, including a yearly domestic immersion experience, a health equity leadership workshop series, mentorship with faculty and national board of advisors and a required capstone project.

## UNC and Strathmore Students Analyze Impacts of Universal Healthcare in the US and Kenya

For the third year in a row, UNC Kenan-Flagler and Strathmore Business School have partnered in a cross-continental learning opportunity, this time with a focus on evaluating the impact of universal healthcare in both the US and Kenyan healthcare systems.

In November and December 2022, students met virtually each week to learn about each country's unique challenges and to analyze best practices applicable across both cultures. Specifically, the course explored the concepts, challenges, opportunities, financing, and implementation of universal health coverage and the special role innovation can play in advancing those endeavors.

#### BAHM Global Case Competition Hosted by Baylor University: Five Student Teams Recognized for "Hospital of The Future" Solutions to the Rural Healthcare Crisis

BAHM's global student case competition, hosted by the Baylor University Hankamer School of Business Robbins Institute for Health Policy and Leadership, envisioned "the hospital of the future" to address the need for sustainable long-term care in underserved communities around the world. Participating in the event on April 8, 2022, were more than 60 MBA students from BAHM-member universities in North America, Costa Rica, India, Kenya, and Spain. Students unable to attend in person participated virtually, and synchronously.

An international group of distinguished academics and healthcare and hospital industry leaders scored the winning teams:

- **Baylor University (1st place):** Stephanie Dodgen, Cholan Wijekumar, Joseph Spear: A rural health alliance serving the East Oklahoma Native American population by linking six rural hospitals, centralizing contracting, partnering with specialists, and providing home health, mobile health, and telehealth services.
- University of Minnesota (2nd place): Ikram Khan, Yu-Hsiang Hung, Erin Green, Dan Muggee: An integrated health system for Jharkhand, India, focused on community health workers who provide basic health services and education and the referral of more acute cases to specialty practitioners.
- Boston University (3rd place): Leah Levine, Lucia Ryll, Christina Young, Evan Piccirillo: A critical access hospital in Downeast Maine financed through an accountable care organization, allowing for the redistribution of funds toward

preventive care and creating the financial flexibility for innovative system integration.

- Baylor University / Indian School of Business (4th place): Riley Griffin, Katherine Griffith, Dr. Vijay Karan Reddy: Community-based health resource guides and councils, provider partnerships and transportation solutions integrated to support the rural American Indians of Oklahoma.
- Indian School of Business (International Judges Award): Jyotiprava Pattanaik, Bikash Sahu, Sriram Chavali, Praveen Gopan: A "hub and spoke" model involving private, public, philanthropic and community stakeholders to deliver holistic population health services in a remote, resourceconstrained area in Odisha, India. (This new award was selected by industry leaders in the U.S. and abroad who acted as 2021 competition judges)

The case competition has always been an annual BAHM focus, with most events held on BAHM-member campuses. However, the pandemic necessitated all-virtual events in 2020 and 2021, promoting collaboration across campuses and continents.

The 2023 BAHM global case competition is hosted by the Yale School of Management and, like Baylor's, is a hybrid event open to BAHM-affiliated students worldwide.

#### ARMY-BAYLOR

**The Army-Baylor University Graduate Program in Health and Business Administration is located at Fort Sam Houston, San Antonio, Texas.** The two-year program consists of a didactic phase and a residency phase. During the 12-month didactic phase at Fort Sam Houston, Army-Baylor students complete 57 hours of graduate coursework towards the 66 hours required for a Master of Health Administration (MHA) awarded by the Baylor University Graduate School. Alternatively, dual tracked students complete 78 hours to be applied towards the 87 credit hours needed for the joint MHA/ MBA degree from the Baylor University Graduate School and Baylor University School of Business. The Program is fully accredited by the Commission on Accreditation of Healthcare Management Education (CAHME) and the joint MHA/MBA degree is awarded with accreditation standing from the Association for the Advancement of Collegiate Schools of Business (AACSB).

In the second year, students complete a 12-month Administrative Residency to complete the remaining 9 credit hours towards the respective degree(s). Residency provides students an opportunity to integrate graduate management and health administration concepts and principles in an applied setting under the mentoring supervision of a highly qualified preceptor. Residents receive thorough exposure to various organizational challenges in the marketplace and complete a portfolio of projects to enable organizations to operate more efficiently and effectively.

Since the last CAHME accreditation in 2014, the Army-Baylor program offers the one-year Executive Clinical Leadership (ECL) accelerated track for military officers with significant clinical experience. The ECL track embeds residency requirements into the didactic year to reduce the time away from patient care. The Army-Baylor Program was recently reaccredited by CAHME in Fall 2022.

The <u>Health Care Initiative at Harvard Business School (HBS)</u> seeks to impact managerial practice and the pace of

**innovation** by educating leaders and innovators who aspire to improve value across the health care industry. The Initiative's priorities are to foster and promote faculty research; support the development of a portfolio of high-impact educational programs; and create an interconnected HBS health care community.

Five second-year MBA courses focus on health care including, Lab to Market, Innovating in Health Care, Transforming Health Care Delivery, and US Health Care Strategy.
